Regular combat report – situation at 17:00 hrs

MAIN STAFF OF THE RS /*Republika Srpska*/ ARMY

IKM /*forward command post*/ - Trnovo

1. ENEMY:

In the 2nd Slpbr /*Sarajevo light infantry brigade*/ z/o /*area of responsibility*/ at 06.00 hrs in the morning, the enemy opened a fierce fire at the “Famos” factory, the settlement of Grlica and Vojkovići from the area of Gradina – Igman and Lasica. They used infantry weapons, rifle grenades, RB /*handheld rocket launcher*/ and 82 mm MB /*mortar*/, PAM /*anti-aircraft machine-gun*/ and sniper rifles. Shooting continued in the morning hours. One “Famos” employee was killed and 2 women and 1 civilian were wounded.

Only two vehicles were seen on the Trnovo axis yesterday between 21:20 and 22:00 hours, moving from Hojta towards the village of Dujmovići – there was probably a rotation of troops.

In 1st Smbr /*Sarajevo mechanised brigade*/ z/o the enemy was firing at Grbavica, the Jewish Cemetery, Dobrinja 4 and Dobirinja 1 from infantry weapons, RB and rifle grenades. One girl and 1 woman civilian were wounded.

In Ilidža pbr /*infantry brigade*/ z/o the enemy was firing from infantry weapons between 21:00 and 01:30 hrs from Stupsko brdo at Nedarići and Kasindol. There were no casualties.

In Igman pbr z/o a re-grouping was noticed in the area of Borak and Gradelj.

In Ilijaš pbr z/o the enemy launched mortar mines yesterday between 15:40 and 16:20 from Očevlje at Nabožić, and between 15:00 and 19:00 hrs they opened infantry fire from Vlajčić at tt /trig. point/ 708. At 20:00 hrs they started shooting from infantry weapons from K. 837 /elevation/ at the area of Misoča canyon and around 23:00 hrs from the area of Kosa at Mandino brdo /Manda's hill/ . At around 08:45 in the morning they opened a sniper fire from the area of Popovići at the area of Mrakovo and around 15:00 they launched one MB mine from Očevlje at the suburbs of Ilijaš. On 6 April around 17:55 in the area of Kula banjer, a group of 4 enemy soldiers were observing our positions in Čekrčići.

In 3rd Spbr /Sarajevo infantry brigade/ z/o today at 14:10 the enemy launched three rifle grenades aiming at Zabrdce. There were no casualties.

2. OUR FORCES

We responded to enemy fire as follows:

- In Iliđa pbr by infantry arms, PA /anti-aircraft/ gun and 82 mm BSt /recoilless gun/
- In Iliđa pbr one 120 mm mine was fired and one 250 kg AB /aerial bomb/ was launched at the centre of Hrasnica. According to the interception centre, the Muslims claim that the "Luna" rocket landed.
- In the 2nd Slpbr z/o we responded to enemy attacks by infantry weapons, 60, 82 and 120 mm MB.

The units were engaged in tasks of the additional preparing of positions, fortified observing and monitoring the situation on lines of contact and preventing the enemy from achieving any significant success.

SRK Command and brigade organs are controlling the situation in units and are taking measures aimed at the implementation of the tasks set.

3. Situation in the territory:

- Problems with the UNPROFOR emerged in the Ilidža pbr z/o yesterday around 21:15 when the UNPROFOR fired at our positions in the area of the Forestry School, following our shooting at the Hrasnica-Igman road. After that they came closer to the position of our “Browning” (DŠK) */heavy machine gun/* The situation calmed before 24.00 hrs. However, today around 07:30 in the morning, an UN unit positioned 4 APCs near our checkpoint in Nedžarići and later on 2 tanks as well, hindering normal contact between Nedarići and the Airport settlement. The Brigade blocked the UNPROFOR.

- Following the injuring of a 4-year old Nikolina PANDUREVIĆ (a daughter of our disappeared combatant Dragan PANDUREVIĆ), population and the combatants of 1/3. pb */infantry battalion/* expressed deep dissatisfaction and revulsion and therefore the company commander temporarily moved away – detained two UN observers (an Englishman and a Jordanian) who came to perform an on-site investigation. During the shooting and injuring of the child, the UN members on Debelo brdo took shelter and immediately after they came out, preventing our units from firing back. The UN members on Debelo brdo conducted improperly even before, showing sympathy for the Muslim side. In particular, they supported the Muslim side in constructing shelters and moving towards our positions. The UN monitors were transferred to the “SVČ” */Slaviša Vajner Čiča/* barracks and the security organ is responsible for them.

- The NATO airplanes performed 25 flights in the SRK zone with 54 overflights among which 9 were over Bjelašnica, 6 over Hrasnica, 5 over Ilijaš, and 4 over Breza, Rajlovac and Umčani respectively. There were some low flights as follows: over Okruglica at 2,900 m between 13.24 and 13.31, over Vojkovići at 2.400 m and over Kalauzovići at 2.300 m. There were no problems with planned airplane and helicopter flights through the airport.

4. Special events:

On 6 April 1995 a Russian volunteer GAVRILIN Dmitrič from 5/3 pb – 1st Smb, born in 1963, was killed under unidentified circumstances. The body was

transferred to the morgue and circumstances are being identified. It is probably the case of squaring accounts among Russian volunteers.

- While checking a minefield in the area of Srednje, a soldier Dragan MIJANOVIĆ from 3rd Spbr activated a mine, and has been seriously injured.

5. Security and morale:

Without significant changes and with permanently expressed dissatisfaction of soldiers because they do not receive their salary. They suggested the distribution of family parcels.

6. PoOb /logistics support/ is functioning with difficulties.

7. Casualties:

- a) Killed: GAVRILIN, Dmitrič, 1963 – 1 Smbr, under “Special events”; LALOVIĆ, Ratko, 1937, a “Famos” employee, by an enemy mine;
- b) Wounded: MIJANOVIĆ, Dragan – 3rd Spbr, seriously injured by an activated mine while checking a minefield; CINCAR, Slobodan – 3rd Spbr, seriously injured by a sniper rifle at Borije (coming from the direction of Jarčedoli) in the shoulder; a girl injured by a sniper rifle – the area of Vrace, treated in the Kasindo hospital, in stable condition; 3 women – civilians injured: 2 in the area of Grlice, 1 in the area of Grbavica and 1 civilian in the area of Grlice.

8. Conclusion, expectations, decision:

- Enemy activities on all axes and lines of contact have been intensified. They use all kinds of weapons and artillery pieces, in presence and with assistance of the UN forces on certain locations. It is to be expected that the enemy will continue deploying their forces and using the weapons intensely, especially on the axes where they consider our units being weak.
- Measures are being taken to ensure that lines and positions are constantly prepared to prevent the enemy incursion and to reduce the impact of their actions.

- The decision on the deployment of the SRK units remains the same.

GLAVNOM ŠTABU VOJSKE RS
IKM - Trnovo

1. NEPRIJATELJ:

U z/o 2.Slpbr neprijatelj je jutros oko 06.00 časova otvorio jaku vatru po Fabrici "Famos", naselju Grlica i Vojkovići iz rejona Gradina - Igman i Lasice. Koristio je streljačko naoružanje, tromblone, RB i MB-82 mm, PAM i snajper. Dejstvo je produžio u toku prepodneva. Od dejstva je poginuo jedan radnik "Famosa", a ranjene su 2 žene i 1 civil.

Na trnovskom pravcu uočeni su samo pokreti 2 vozila sinoć između 21.20 i 22.00 časa, od Hojte prema s.Dujmovići - verovatno je vršena smena.

U z/o 1.Smbr dejstvovao je po Grbavici, Jevrejskom groblju, Dobrinji 4 i Dobrinji 1 streljačkim oružjem, RB-om, tromblonskim minama. Od dejstva je ranjena 1 devojčica i 1 žena civil.

U z/o Iliđanske pbr otvarao je vatru iz pešadijskog naoružanja od 21.00 do 01,30 časova sa Stupskog brda po Nedjarićima i Kasindolu. Posledica nije bilo.

U z/o Igmanske pbr uočeno je pregrupisavanje u rejonu Borak i Gradelj.

U z/o Ilijaške pbr dejstvovao je sa MB mine juče od 15.40 do 16.20 časova sa Očevlja po Nabožiću, a u 15.00 do 19.00 časova sa Vlajčića pešadijskom vatrom po tt.708. Oko 20.00 časova sa K.837 dejstvovao je pešadijskim oružjem po rejonu kaonjona Mišoče, a oko 23.00 iz rejona Kose po Mandinom brdu. Jutros oko 08.45 časova iz rejona Popovići otvarao snajpersku vatru po rejonu Mrakovo, a oko 15.00 sa Očevlja gadjao jednom MB minom po prigradskom delu Ilijaša. U rejonu Kule banjer oko 17.55 o6.04. grupa od 4 neprijateljska vojnika vrši osmatranje naših položaja u Čekrčićima.

U z/o 3.Spbr danas u 14.10 dejstvovao je sa 3 tromblonske mine po Zabrdju. Gubitaka nije bilo.

2. NAŠE SNAGE:

Na vatru neprijatelja odgovoreno je po sledećem:

- u Ilijaškoj pbr pešadijskim oružjem, PA topom i BSt 82 mm,
- u Iliđžanskoj pbr dejstvovano je 1 minom od 120 mm i lansirana 1 AB 250 kg po centru Hrasnice. Po prislušnom centru muslimani tvrde da je pala raketa "Luna",
- u z/o 2.Slpbr na neprijateljsko dejstvo uzvraćeno je streljačkim oružjem, MB 60, 82 i 120 mm.

Jedinice su angažovane na zadacima dopunskog uredjenja položaja, pojačanom osmatranju i praćenju situacije na linijama dođira, kao i sprečavanju neprijatelja da svojim dejstvom postigne veći uspeh.

Organi K-de SRK i brigada vrše kontrolu sagledavanja stanja u jedinicama i preduzimaju mere za realizaciju postavljenih zadataka.

3. Stanje na teritoriji:

- Problemi sa UNPROFOR-om u z/o Iliđžanske pbr pojavili su se od 21.15 časova sinoć kada je UNPROFOR dejstvovao po našim položajima u rejonu Šumarske škole, nakon našeg dejstva po putu Hrasnica-Igman, a potom se približio poziciji - položaju našeg "Browinga" /DŠK/. Situacija je smirena do 24.00, ali je jutros oko 07.30 jedinica UN kod našeg kontrolnog punkta u Nedjarićima postavila 4 transportera, kasnije i 2 tenka, čime je onemogućen normalan kontakt Nedjarića sa Aerodromskim naseljem. Brigada je izvršila blokadu UNPROFOR-a.

- Nakon ranjavanja četvorogodišnje Nikoline Pandurević /kćerke našeg nestalog borca Dragana Pandurevića/ došlo je do velikog izliva nezadovoljstva i revolta stanovništva i boraca 1/3.pb, pa je k-dir čete privremeno sklonio - pritvorio dvojicu posmatrača UN /Engleza i Jordanca/ koji su se pojavili na licu mesta radi uvidjaja. U vreme otvaranja vatre i ranjavanja deteta pripadnici UN na Deblom brdu su se sklonili u zaklone a odmah potom izašli ispred istih čime su onemogućili odgovor vatrom iz naše jedinice. I ranije je bilo nekorektnog ponašanja pripadnika UN na Debelom brdu izraženo kroz naklonjenost muslimanskoj strani, posebno kroz podršku pri izradi zaklona i primicanju našim položajima. Posmatrači UN su predati organu bezbednosti u kasarni "SVC".

- Avioni NATO izvršili su 25 letova u zoni SRK sa 54 preleta od čega preko Bjelašnice 9, Hrasnice 6, Ilijaša 5, Breze, Rajlovca i Umčana po 4 preleta. Niski letovi vršeni su preko Okruglice od 13.24 do 13.31 časova na 2.900 m, Vojkovića na 2.400 m i Kalauzovića na 2.300 metara. Planirani letovi aviona i helikoptera preko aerodroma vršeni su bez problema.

4. Vanredni događaji:

Dana 06.04.1995.godine pod još nerasvetljenim okolnostima ubijen je ruski dobrovoljac Gavrilin Dmitrič iz 5/3.pb - 1.Smbr, 1963.god. Telo je smešteno u mrtvačnicu, a utvrđuju se okolnosti. Verovatno se radi o međusobnom obračunu ruskih dobrovoljaca.

- Pri vršenju kontrole minskog polja vojnik Mijanović Dragan iz 3.Spbr, u rejonu Srednjeg aktivirao je minu, pri čemu je teže ranjen.

5. Stanje bezbednosti i morala:

Bez bitnih promena uz stalno izraženo nezadovoljstvo zbog toga što se vojnicima ne dele nikakve plate, a predlaže se podela porodičnih paketa.

6. PoOb sprovodi se otežano.

7. G u b i c i:

a/ Poginuli: Gavrilin Dmitrič, 1963. - 1.Smbr, u vanrednom događaju; Lalović Ratko, 1937. radnik "Famosa" od neprijateljske mine;

b/ Ranjeni: Mijanović Dragan - 3.Spbr, teže ranjen pri kontroli minskog polja od aktiviranja mine; Cincar Slobodan - 3.Spbr, teže ranjen snajperom na Borijama /dejstvo iz pravca Jarčedoli/ u predeo plečke; ranjena djevočica od dejstva snajpera - rejon Vraca, zbrinuta u bolnici Kasindo, van životne opasnosti; ranjene 3 žene - civili: 2 u rejonu Grlice, 1 u rejonu Grbavice i 1 civil u rejonu Grlice.

8. Zaključak, predvidjanja, odluka:

- Dejstvo neprijatelja na svim pravcima i linijama dodira je intenzivirano, a koriste se sve vrste raspoloživog orudja i oružja, uz prisustvo i pomoć snaga UN na pojedinim tačkama. Očekivati je i u narednom periodu intenzivnu upotrebu snaga i sredstava, posebno na pravcima gde neprijatelj ceni da u našim jedinicama ima slabosti.

- Preduzimaju se mere da linije i položaji budu u stalnoj spremnosti za sprečavanje prodora neprijatelja i smanjivanje efekata njihovog dejstva.

- Odluka za upotrebu jedinica SRK nije promenjena.
